- I. Article III of the By-Laws of said Spanish Gardens I, as recorded on December 4, 1973, at Docket 10422, at Pages 247-282 of the records of the Maricopa County, Arizona, Recorder is hereby amended so that Article, Section, reads as follows:

## Amendment I.

- 3.4 NOTICE OF MEETINGS. It shall be the duty of the Secretary to deliver or mail to each Member a notice of each annual or special meeting of the Members, stating the purpose thereof and the time and place where such meeting shall be held. Such notice shall be mailed or delivered at least thirty (30) days prior to such meeting to the owner at his address as it appears on the Association's official membership list, or if no such address appears, his last known address.
- II. Article V of the By-Laws of said Spanish Gardens I, as recorded on December 4, 1973, at Docket 10422, at pages 247-282 of the records of the Maricopa County, Arizona, Recorder is hereby amended so that Article, Section, reads as follows:

## Amendment II.

5.10 DUTIES OF THE SECRETARY. The Secretary shall record the votes and keep the minutes of all meetings of the Members and the minutes of all meetings of the Board of Directors, and to distribute to each homeowner, following each meeting of the Board of Directors, the minutes of monthly meetings no later than the third week after the meeting, keep the corporate seal of the Association and affix it on all papers requiring said seal, service notice of meetings of the Members and the Board of Directors, maintain the current official list of Members of the Association together with their current addresses and shall perform such other duties as required by the Board.
