CERTIFICATE OF AMENDMENT TO COVENANTS, CONDITIONS AND RESTRI OF SPANISH GARDENS I TOWNHOUSE ASS

- I, William Campbell, hereby certify that I am the President of Spanish Gardens I Townhouse Association, an Arizona non-profit corporation, and that I have in my possession an instrument signed by in excess of seventy-five percent (75%) of the lot owners of lots one (1) through seventy-six (76) inclusive, according to the plat of record in the office of the County Recorder of Maricopa County, Arizona, in Book 168 of Maps, Page 23 thereof; Maricopa County, Arizona, approving the Amendment of the Declaration of Covenants, Conditions and Restrictions of said Spanish Gardens I Townhouse Association, which Declaration was recorded on December 4, 1973, in the office of the Maricopa County Recorder, Maricopa County, Arizona, Docket 10422, at Pages 247-282, as follows:
- I. Article II of the Declaration of Covenants, Conditions and Restrictions of said Spanish Cardens I, as recorded on December 4, 1973, at Docket 10422, at Pages 247-282 of the records of the Maricopa County, Arizona, Recorder is hereby amended so that Article II, Section I, reads as follows:

ARTICLE II. MAINTENANCE, REPAIRS AND REPLACEMENTS.

Each owner shall furnish and be responsible for, at his own expense, all the maintenance, repairs and replacements within his own unit. Maintenance, repairs and replacements on the common elements shall be furnished by the Association as part of the common expenses, subject to the By-Laws and rules and regulations of the Association. If, due to the wilful or negligent act of an owner or a member of his family or household pet or guest or other authorized occupant or visitor of such owner, damage shall be caused to the common elements or to a unit or units owned by others, or maintenance, repairs or replacements should be required which would otherwise be at the common expense, then such owner shall pay for such damage and for such maintenance, repairs and replacements as may be determined by the Board to the extent not covered by the Association insurance. An authorized representative of the Board, or of the manager or managing agent of the building, and all contractors and repairmen employed or engaged by the Board, or such manager or managing agent, shall be entitled to reasonable access at reasonable times to each of the units as may be required in connection with maintenance, repairs or replacements of or to the common elements or any equipment, facilities or fixtures affecting or serving other units and the common elements.

II. Article II of the Declaration of Covenants, Conditions and Restrictions of said Spanish Gardens I, as recorded on December 4, 1973, in Docket 10422, at Pages 247-282 of the records of the Maricopa County, Arizona, Recorder is hereby amended by adding Section I thereto, which reads as follows:

SECTION 1.

Each owner(s) shall be responsible for the upkeep of his own roof. This would include repair, maintenance and replacement of said roof, the only restriction being that of maintaining design unity with the total complex. Also, each owner(s) would hold the Association and the Board of Directors of Spanish Gardens I harmless in any action resulting in failure of any owner(s) who does not make said repairs and causes damage to his unit or his neighbor's unit.

This amendment also is in addition to Article 17, Section I, recorded on the 28th day of December, 1976, at Docket \$12009, at Pages 674-676.
